HAITI AND THE DOMINICAN REPUBLIC SHARE THE ISLAND OF HISPANIOLA AND ARE EXPOSED TO VERY SIMILAR, IF NOT THE SAME, HAZARDS-EARTHQUAKE FAULTS SPAN THE TWO COUNTRIES, TSUNAMIS GENERATED FROM OFFSHORE EARTHQUAKE FAULTS THREATEN COASTAL COMMUNITIES IN BOTH COUNTRIES, AND TROPICAL STORMS AND HURRICANES HITTING THE ISLAND AFFECT THE TWO COUNTRIES. THESE TWO COUNTRIES ALSO FACE SIMILAR CHALLENGES, BEING SMALL ISLAND NATIONS WITH LOW RESOURCES. OUR PROGRAM IN THE AREA FOCUSES ON EQUIPPING AT-RISK COMMUNITIES IN THESE COUNTRIES WITH ACTIONABLE INFORMATION ON REDUCING THEIR RISKS FROM DISASTERS. OUR PROGRAMS INCLUDE YOUTH-LED EFFORTS IN BUILDING DISASTER RESILIENCE IN THEIR OWN COMMUNITIES, AS WELL AS SUPPORT FOR AREAS AFFECTED BY THE AUGUST 2021 EARTHQUAKE IN SOUTHERN HAITI. THROUGH THESE EFFORTS WE WORK CLOSELY WITH SCHOOLS, CHURCHES, AND OTHER LOCAL LEADERS.

THERE IS NO QUICK FIX TO STRENGTHEN COMMUNITIES IN THE FACE OF DISASTERS. RESILIENCE REQUIRES PEOPLE WORKING LONG-TERM ON MANY LEVELS- LOCAL PEOPLE WHO ARE BEST PLACED TO LEAD AND IMPLEMENT CHANGE. TO STRENGTHEN COMMUNITIES IN THE FACE OF DISASTERS, WE INVEST IN ADVOCACY, OUTREACH, AND MENTORING ACROSS THE COMMUNITY SPECTRUM. WITH NEW KNOWLEDGE AND CAPACITIES TO BUILD RESILIENCE, THESE PATHFINDERS WILL STEER LASTING IMPACT IN THEIR COMMUNITIES. OTHER PROGRAMS INCLUDE EFFORTS TO RAISE AWARENESS OF EARTHQUAKE RISK IN AT-RISK COMMUNITIES WITHIN LOW- AND MIDDLE-INCOME COUNTRIES. THE DISSEMINATION OF INFORMATION ABOUT EARTHQUAKE RISK AND HOW GHI SEEKS TO REDUCE THAT RISK OCCURS THROUGH NEWSLETTERS, PRESS RELEASES, A WEBSITE, WORKSHOPS, MEETINGS, SEMINARS, SPEAKING ENGAGEMENTS, AND EVENTS. RESOURCES OF TIME AND ENERGY ARE ALSO SPENT COLLABORATING WITH OTHER ORGANIZATIONS THAT ADDRESS RELEVANT ISSUES IN ORDER TO STRENGTHEN THE EFFECTIVENESS OF GHI.
